Mustacchio read the Budget Message for 2021- Borough Budget is a balance budget of \$3,833,500, and the Light Department Budget of \$3,886,100, there is no tax increase.

A motion was made by Tully and seconded Krukovitz present the 2021 Tentative Budget for the Borough and the Borough Light Department, Summary Budget Reports by Manager; announce adoption of the final budgets at the December 15, 2020 Regular Session of Council at 6:30 PM by Zoom Conference and to grant the authorization to Advertise as such, on the question Harrington asked did we get the extra money for the Police Department, Mustacchio said it was from Electrical Department savings, Tully complimented Mustacchio on his hard on working on the budget; all members assented.

A motion was made by Tully and seconded by Krukovitz to present the 2021 Tax Rate Ordinance providing for the total rate of 10/6 mills to be adopted at the December 15, 2020 Meeting subsequent to adoption of final 2021 Budget; all members assented.

A motion was made by Abda and seconded by Harrington to Authorize the newspaper advertisement for the 2021 Meeting Schedules for the Olyphant Borough Regular Sessions,

the Work Sessions, the Light Committee meetings and the Planning Commission meetings; all members assented.

LaFratte said the Borough receive \$35,000 from the county for equipment to help the Borough with meeting Co-vid protocol; The Police received a \$5,000 grant from the County; Tully compliment the Mayor and the Police Department, they participated in the arrest of 22 drug dealers.
